# NOTIFICATION

Hon'ble the Chief Justice, High Court of Sikkim, in exercise of the powers conferred under Article 229 of the Constitution of India and all other power enabling him in this behalf is pleased to make the following Rules further to amend the High Court of Sikkim (Recruitment, Conditions of Service and Conduct) Rules, 1998.

# 1. Short title, commencement and application:

- (i) These Rules may be called "The High Court of Sikkim (Recruitment, Conditions of Service and Conduct) Amendment Rules, 2023".
- (ii) They shall come into effect on the date of publication in the official gazette.

### 2. Amendments to Schedule-I and II 'A':-

- i. The word 'Zamadar' mentioned at Sl. nos. 35 & 42 of the table at Schedule-I and Sl. nos. 21, 22 & 28 of the table at Schedule -II 'A' of the High Court of Sikkim (Recruitment, Conditions of Service and Conduct) Rules, 1998 shall be substituted with the word 'Zimmedaar' wherever it appears.
