REPORT

In compliance to Notification No. 10/HCS dated 03.05.2018, a report for the period of six month (*i.e.*, 03.05.2018 - 02.11.2018) is prepared as under:-

- [1] CCTV cameras with audio/video recordings installed in all the Subordinate Courts of Sikkim in the year 2017.

 The configuration of CCTV cameras is as per the specifications provided by the Ministry of Law and Justice with minor variance.
- [2] CCTV cameras do not cover proceedings of Family Courts, Special Courts constituted under POSCO Act, 2012, Protection of Women from Domestic Violence Act, 2005, Fast Track Court Cases and Juvenile Justice Boards inquiries.
- [3] CCTV cameras installed in the Court Rooms of the Subordinate Courts of Sikkim are remotely viewed from the Office of Registrar General, High Court of Sikkim at

- Gangtok. The recordings of CCTV cameras are accordingly monitored on daily basis.
- [4] CCTV cameras help in providing transparency of the Court proceedings. Judicial Officers and Advocates are aware of that the Court proceedings are being recorded and monitored. The Courts are taking up cases punctually.
- [5] The configuration of CCTV cameras installed in the Subordinate Courts of Sikkim are as follows:-
