- 2. A candidate for appointment to the above posts must be:-
  - (a) a citizen of India; and
- (b) not less than 18 years of age as on the first day of January of the recruitment year and not more than 40 years of age on the last day of submission of application Form, which shall be uniform age for all communities of the State in the services/posts to be filled up by direct recruitment. Relaxation of upper age limit shall be the same as may be prescribed by the State Government from time to time.
- 3. Candidates fulfilling the above conditions may apply for the post(s) along with all the supporting documents, duly attested and 3(three) recent passport size photographs, to the undersigned. Applications received without supporting documents and photographs will be summarily rejected. Candidates are also required to mention their proper address and mobile/contact numbers in their applications.

- 5. Applications received after the last date **23.11.2019** shall not be entertained on any ground.
- 6. Those who are already in Government service shall apply through proper channel.
- 7. Candidates found eligible on preliminary scrutiny of the applications shall be issued admit cards for appearing in the driving test and interview/ viva-voce, as the case may be. The list of names of candidates found eligible on preliminary scrutiny will be displayed on the Notice Board of the High Court of Sikkim and/or the eligible candidates will be intimated through SMS in their mobile numbers.
